The Educational Trust Fund (ETF) of the Connecticut Society of Certified Public Accountants has established this award to assist students majoring in accounting who have a parent holding membership in the Connecticut Society of CPAs. The ETF will be providing awards of **\$500** each to selected scholarship recipients at the ETF Awards Dinner on Thursday, November 4, 2010. Attendance at the awards dinner is strongly suggested for scholarship recipients.

**TO BE ELIGIBLE FOR A CHILDREN OF CSCPA MEMBERS SCHOLARSHIP YOU MUST:**

1. Be the son or daughter of a CSCPA member in good standing;
2. Be enrolled at a college or university in an accredited accounting program leading to qualification to sit for the CPA exam;
3. Have an overall grade point average (GPA) of 3.0 or above and an accounting GPA of 3.0 or above.
4. Have at least 75 credits, of which at least 12 credits are in accounting courses, that have been or will be completed by the end of the current semester, and have at least two semesters of undergraduate course work remaining.

***Please note: Previous Children of CSCPA Members award recipients are not eligible to apply. Applicants must meet the criteria stated above at the time of application deadline.***

1. Include an official copy of your college or university academic transcript.

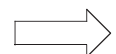
