“FRANK FRAGO COMMUNITY SERVICE AWARD” APPLICATION

When Frank C. Frago, CPA passed away on July 18, 2007 the CSCPA lost more than a loyal member and leader, we lost a great friend. Frank joined the Connecticut Society of CPAs in 1960 and quickly became an active volunteer, chairing and serving on numerous committees, groups, and task forces. Frank’s peers eventually elected him to the CSCPA Board of Governors, after which he rose through the various officer positions to serve as CSCPA President in 1981-1982.

Following Frank’s year in office, he served on and chaired the Educational Trust Fund (ETF). Accordingly, the CSCPA recognized Frank with its most distinguished honor, that for the Meritorious Service, in 1998. But Frank’s service and leadership extended far beyond the CSCPA, for he shared his expertise and time with his friends, colleagues, and community alike with such organizations as his local chamber of commerce and Lions Club.

This, the Frank Frago Community Service Award, will give special consideration to an accounting student who has actively demonstrated exemplary public service, in recognition of Frank’s history of supporting not only his profession but his community.

The Educational Trust Fund (ETF) of the Connecticut Society of Certified Public Accountants has established this annual award to encourage and recognize undergraduate accounting majors who have shown leadership through continued commitment to community service. The ETF will be providing a cash award of **\$750** to the selected scholarship recipient during the ETF Awards Dinner on **November 4, 2010**. Attendance is expected for the scholarship recipient.

TO BE ELIGIBLE FOR THE FRANK FRAGO COMMUNITY SERVICE AWARD YOU MUST:

1. Be a declared undergraduate accounting major with junior or senior standing at the time of the application deadline;
2. Demonstrate a history of and a commitment to community service activity; and
3. Currently be a resident of the state of Connecticut and/or currently enrolled in a four-year college/university recognized by the Connecticut State Board of Accountancy and located in the state of Connecticut.

Applicants must meet the criteria stated above at the time of application deadline.

APPLICATIONS MUST INCLUDE:

1. A one-page, (double-spaced) statement demonstrating your community service activities and why you should be considered for this award. Please specify how your community service activities demonstrated your leadership skills, as well as your role in the activity, and why you participated.
2. A copy of your Driver’s License.
3. An official copy of your college or university academic transcript.
4. One recommendation letter that should address the applicant’s demonstrated community service/volunteerism and leadership skills.
5. Completed application and attachments specified above must be postmarked on or before **September 17, 2010** and submitted to:
